#### **Council Member Assists Border Patrol**

Council board member, John Thoma (USCG Auxiliary) received voluntary orders to report to the U.S. Customs and Border Patrol Eagle Pass, TX migrant processing center for the months of July and October 2022 to support ongoing migrant surge activity. The USCG Auxiliary assumed some positions and that allowed the Border Patrol to move some CBP agents back on the line and to support migrant processing. Duties included both administration and logistical support within the processing center in a non-law enforcement role under the supervision of CBP management. Duties also included stocking supplies in the migrant

holding area. In their off time they visited the actual border and witnessed the migrants fighting to cross the Rio Grande River at Eagle Pass. It was an incredible experience. The United States Border Patrol is the mobile, uniformed law enforcement arm of U.S. Customs and Border Protection within the Department of Homeland Security responsible for securing U.S. borders between ports of entry. The Border Patrol was officially established on 28 May 1924, by an act of Congress passed in response to increasing illegal immigration. As mandated by this Act, the small border guard in what was then the Bureau of Immigration was reorganized into the Border Patrol. The initial force of 450 officers was given the responsibility of combating illegal entries and the growing business of human smuggling.

CAPT Saboe presented a synopsis of CG history and legal authority and detailed operations in the Pacific Northwest including international cooperation with Canada in fisheries and border operations, Arctic operations by CG ice breakers stationed in Seattle and CG small boat and vessels operating in the Middle East. CAPT Joshua Menzel USN, Commanding Officer of Naval Station Everett as "host" for all of the US Navy and US Coast Guard tenant commands attending the dinner welcomed everyone on behalf of Naval Station Everett. He presented a "state of the station" and condensed history of Naval Station Everett along with several interesting numerical facts including the station refueling all vessels with 3.7 million gallons of fuel without any spills. Naval Station Everett dependents are in 13 different school districts. Recently, to prepare for heavy rains and prevent additional flooding, Navy environmental staff collaborated with biologists from the Tulalip Tribe to carefully trap and relocate 13 beavers to another place where they can build dams that will create new wetland areas instead of causing damage in Naval Station Everett's expansive outdoor recreation areas at Jim Creek, a Navy-preserved old growth forest, trails, and mountain lakes outdoor recreation area which includes campgrounds. Sanu followed CAPT Menzel by stating that all commands at Naval Station Everett are officially supported units of

the Lake Washington and Everett Council. Sanu thanked CAPT Menzel and CMDCM Shelly Zakimi, the Command Master Chief of Naval Station Everett, for support of the council. Sanu then recognized Sailors of the Quarter (SOQ), Sailors of the Year (SOY), Blue Jacket of the Year and Quarter (BJOY), Senior Sailor of the Quarter (SSOQ), Junior Sailor of the Quarter (JSOQ) and Coast Guard Enlisted Person of the Year (EPOY) for seven Navy and Coast Guard commands. Sanu also recognized two individual Naval Sea Cadet awards. Following the recognition of all award

### USCGC Healy (WAGB 20) Returns Home from Deployment



USCGC Healy (WAGB 20) returned to its Seattle homeport on 11 November following a historic 17,000-mile, 124-day deployment in the high Arctic latitudes that included a transit to the North Pole. The crew's efforts demonstrated interoperability in the Polar Region, supported U.S. security objectives, and projected an ice-capable presence in Arctic waters and the Gulf of Alaska. "It is more important than ever before to provide security and sovereign presence in the Arctic and ex-


Kenneth Boda, USCG, Commanding Officer. "The crew of Healy is proud to have completed this mission to the North Pole and back, advancing American interests across the Arctic Ocean." Healy's crew traversed the ice-packed Arctic Ocean to the top of the world, reaching the geographic North Pole on 30 September. This was only the second time a U.S. surface vessel had reached 90 degrees north unaccompanied. In July and August, after a port call in Seward, AK, Healy traveled into the Beaufort and Chukchi Seas, going as far north as 78 degrees, while supporting an Office of Naval Research-sponsored team from the University of Washington Applied Physics Department and Woods Hole Oceanographic Institution. The embarked team worked with Healy crew to conduct various evolutions, including deploying and recovering sea gliders, underwater sensors and acoustic buoys, throughout the marginal and pack ice zones as part of the Arctic Mobile Observing System. During transits to and from the Arctic, Healy participated in flight operations in Kotzebue Sound and off the coast of Kodiak Island, AK, with CG Air Station Kodiak MH -60 helicopter aircrews, conducted passing exercises with the USCGC Kimball (WMSL 756), and completed patrols of the international maritime boundary line between the U.S. and Russia. In September and October, after a port visit to Dutch Harbor, AK, Healy transited north again to conduct multidisciplinary, internationally collaborative research as part of the Synoptic Arctic Survey. The embarked National Science Foundation-funded team collected samples and data to study environmental changes across the Arctic Ocean. Upon reaching the North Pole, Healy conducted two days of science operations and the crew enjoyed several hours of ice liberty. After disembarking all science personnel during a second logistics stop in Dutch Harbor at the end of October, Healy made a final port call in Juneau, AK, where friends and family of crewmembers were given the opportunity to sail on the cutter during its final underway leg through the inside passage to Seattle. The Coast Guard provides the United States' most active and visible surface presence in Polar Regions and is currently recapitalizing its polar icebreaker fleet to ensure continued access to these regions in support of the Nation's economic, commercial, maritime and national security needs. The operational polar fleet



currently includes the Healy and the USCGC Polar Star (WAGB 10), a 399-foot heavy icebreaker commissioned in 1976. These cutters are designed for open-water icebreaking and feature reinforced hulls and specially angled bows. Polar security cutters will enable the U.S. to maintain defense readiness in the Arctic and Antarctic regions; enforce treaties and other laws needed to safeguard both industry and the environment; provide ports, waterways and coastal security; and provide logistical support – including vessel escort – to facilitate the movement of goods and personnel necessary to support scientific research, commerce, national security activities and maritime safety.

For readers who do not know what an FRG is, the explanation below is from military.com:

What an Family Resource Group (FRG) Does How your FRG operates will depend on which branch of service your spouse is in, but all of them will try to:

- Distribute any relevant command information to the family members of the unit.
- Act as a support and communication bridge between the command and the families of the unit.
- Help connect you to and advocate for the community resources at your disposal.
- Help you solve problems that arise while your spouse is affiliated with the command.
- Make you feel as ready, resilient and connected as possible.

#### **Pearl Harbor facts**

On the morning of December 7th, 1941, the Wickes-class destroyer USS Ward attacked and sank a midget submarine near the harbor entrance, making it the first shot fired on that day and the first official American shots in the War. The Japanese sub's periscope was spotted above the water by the minesweeper USS Condor, which alerted the USS Ward, who opened fire on the intruder.

The Japanese forces had planned to use their submarines for different tasks before, during, and after the Pearl Harbor attack. Before the attack, submarines were to scout to penetrate the harbor's defenses. Once the air attack started, they were to release their torpedoes and escape back out the channel. After the attack, these submarines were to station in pre-designated spots of the islands to rescue any pilots who couldn't make it back to their carriers. One pilot landed on Niihau (a small island near Kauai). Unfortunately the submarine had long left its position, stranding him there.

In the surprise attack on 'Battleship Row' on December 7th, the USS Arizona and USS Oklahoma were damaged beyond repair by bombs or torpedo hits; most ships returned to service. Of the 2,026 American sailors and marines killed in the attack, 1,606 had been aboard these two ships. Three more battleships (USS California, USS West Virginia, and USS Nevada) sank upright in the shallow harbor water and were salvaged, while many other vessels suffered repairable damage, not returning to the battlefield for several years.

A fact that honors USS Arizona survivors is that crew members who served on board the USS Arizona during the attack may choose to have their ashes deposited by divers beneath one of sunken Arizona's gun turrets. Roughly 44 Arizona survivors have chosen this option. Other military survivors can choose to have their ashes scattered wherever their ship was located during the attacks. USS Arizona had 23 sets of brothers from 37 different families in pairs or trios for a total of 77 men. Only 15 of them survived, which was devastating. This policy was changed due to the tragic events of this day, but many brothers still served together throughout the war, nonetheless.

Japan wrongly concentrated on just destroying battleships of the US Navy as it thought that the Pacific fleet battles would be decided on them. Had Japan focused beyond the fleet and targeted navy repair yards, oil tank farms, submarine base, and the old headquarters building it could have inflicted far greater damage. American aircraft carriers were untouched by the attack (they were out at sea). This led to America rebuilding quickly for war and ultimately reversing the Japanese advance. Admiral Hara Tadaichi summed up the Japanese result, "We won a great tactical victory at Pearl Harbor and thereby lost the war."

The day before the attack, USS Arizona fully loaded nearly 1.5 million gallons of oil which helped ignite the explosion and fires that destroyed the ship, but some fuel still seeps from the wreckage - up to nine quarts of oil into each day. This adds to the emotional gravity of this memorial and those visiting often refer to this phenomenon as the "tears of the Arizona" or "black tears."

Pearl Harbor created a wave of patriotism and outrage. Less than a year later, 50 million of 132 million Americans were employed in the war effort working for the government. This mass industrialism allowed the US Navy to build all classes of vessels quickly, including 77 Gato Class submarines that were built between 1940 and 1944.

Japanese Admiral Isoroku Yamamoto conceived the Pearl Harbor attack and Captain Minoru Genda planned it. Two items inspired Yamamoto's idea: a prophetic book and a historic attack. *The Great Pacific War* was written in 1925 by Hector Bywater, a British naval authority. It was a realistic account of a clash between the USA and Japan that began with the Japanese destruction of the US fleet and an attack on Guam and the Philippines. When Britain's Royal Air Force successfully attacked the Italian fleet at Taranto on 11 November 1940, Yamamoto was convinced that Bywater's fiction could become a reality.

The Japanese attacked Pearl Harbor a second time on 4 March 1942, in Operation K. They used two four engine naval flying boats, nicknamed "Emily" by the allies. With a 10 man crew, it carried a ton of bombs and had a crew of 10. This time radar spotted them, and just after midnight, air defense dispatched fighters to patrol over Pearl Harbor. Unable to see the target due to cloudy weather, one Japanese aircraft dropped bombs on a remote hillside and the other into the ocean.
